Directions:

To disinfect toilet bowls, flush toilet and direct 4 ounces on to the sides of the bowl and under the rim, letting it run down into the water. Let stand a few minutes, then swab bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes, and flush.

For badly stained toilet bowls, flush toilet and use a mop to push water from the bowl over the trap. Press swab mop against bowl to remove excess water. Direct 4 ounces of this thickened product onto the sides of the bowl and under the rim, letting it run down. Allow sufficient time for product to cover entire surface of bowl for maximum cleaning. Swab bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush. To disinfect urinals, flush urinal and direct 4 ounces of this product on to the sides, allowing enough time for complete coverage of the surfaces. Using a scrub brush or toilet mop, scrub urinal surfaces completely. Let stand for 10 minutes and flush.

First Aid:

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink large quantities of water. Avoid alcohol. Call a physician immediately.

Storage:

DO NOT CONTAMINATE WASTE, FOOD, OR FEED BY STORAGE OR DISPOSAL. STORAGE - Store in a dry place now lower in temperature than 50F or higher than 120F. CONTAINER DISPOSAL - Do not reuse empty container. Triple rinse empty container with water. Return metal drum then offer for reconditioning or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Plastic containers may be disposed of in a sanitary landfill, incinerated, or if allowed by local authorities, by burning. If burned, stay out of smoke.
